Customs attends HNPW in Geneva, Switzerland

Following Vanuatu's experience with Tropical Cyclone Pam, Vanuatu Customs was fortunate to be invited by the Office for the Coordination of Humanitarian Affairs (OCHA) to attend the Humanitarian Networks & Partnership Week (HNPW) in Geneva, Switzerland on 6th to 10th February 2016.

The HNPW provides a platform for a vast variety of humanitarian actors to exchange experience and facilitate collaboration in common operational challenges. The program comprised of technical meetings, network meetings as well as internetworks day to facilitate joint discussions and identification of possible common solutions.

Vanuatu's attendance was very insightful as we learnt of how we can better facilitate the clearance of relief supplies with collaboration with the National Disaster Management Office (NDMO). It was also useful to get some ideas of how minimize the issue of Unsolicited

Bilateral Donations or UBD's which was a real issue, even two years after TC Pam.

Vanuatu Customs was represented at this event by Director DCIR, Mr. Benjamin MALAS and NPM, Mr. Stanley TRIEF.

Facilitating Disaster Relief Supplies

And addressing the issue of Unsolicited Bilateral Donations

A takeaway for Vanuatu Customs from the Humanitarian Network Partnership Week (HNPW) was that some simple preparatory work are required to be done now by both Customs and the National Disaster Management Office (NDMO) to prepare both agencies to facilitate disaster relief supplies at the wake of any disaster in Vanuatu.

A new ASYCUDA module created by UNCTAD, called ASYREC (Automated System for Relief Emergency Consignments) was also

presented during the HNPW as a possible solution to facilitate the clearance of relief supplies.

On the other hand, there is also the issue of Unsolicited Bilateral Donations (UBD's) where goodwill donations were sent to Vanuatu unannounced or at very short notice, with faulty or no paperwork, no clearly defined consignee, non-standard items, not appropriate for Vanuatu or the disaster or incorrect packaging. Such donations just create pressure on the

already stretched supply chain during a disaster. They also incur unexpected storage, handling and disposal fees for the Government. Furthermore, UBD's have an impact on the environment when the expired and damaged goods have to be disposed off.

Customs is already having talks with the NDMO to improve facilitation of disaster relief supplies in the future and to put in measures in place to minimize the issue of UBD's.

ASYCUDA World prototype updated with the HS2017

Following the signing of the World Customs Organization (WCO) HS2017 by the Finance Minister, to enter into force on 5th January 2017, the ASYCUDA World prototype server has been updated accordingly by the Project team.

This updating exercise was not straight forward as it involved a lot of cleaning up on the database as well as on the signed HS2017. It was probably the first ever thorough cleanup of the HS since its implementation in Vanuatu back in 1999. This exercise should now allow for better goods classification, improved revenue collection and realistic statistics now and into the future.

The findings of the above exercise was presented to the Customs Reform and Modernization Committee in its February meeting and later forwarded to the Customs Revenue Unit (CRU) for review and action. CRU will be updating the HS2017 accordingly and seek further legislative changes where necessary on the relevant legislations.

With the AW Prototype now updated with the HS2017, the Project team is now in a better position to re-configure the system taxation rules and test the system accordingly.

The 8th CRMC monthly meeting is scheduled for 30th March 2017.



The ASYCUDA (Automated SYstem for CUstoms DAta) software, used by over 90 Customs Administrations around the World, was developed by the United Nations Conference for Trade and Development (UNCTAD). An earlier version of ASYCUDA called ASYCUDA++ was implemented in Vanuatu in 1999.

ASYCUDA++ is a DOS based program with ICT limitations and therefore obsolete in this day and age. UNCTAD has therefore developed a web-based version of ASYCUDA known as ASYCUDA World. It takes advantage of the significant progress made in the field of ICT to provide improved automated support to the evolving requirements of both the Trading Community and Customs administrations.
