The Terms of Reference for this mission was to work with the National Project Team on:

1. Developing the Business Units in the

ASYCUDA World Prototype;

- Further developing the documentation of the processes, which includes the flowcharts, the SOPs and the TORs.
- 3. Preparing the training materials, including a Training schedule and Course Content.
- Working on other technical and functional issues with regards to developing the system prototype.

Mme. DUMONT is expected back in Vanuatu in the first week of November to continue providing more assistance to the National Project Team on the work being done to prepare the ASYCUDA World prototype, and to do further work on the process documentation and training materials

The ASYCUDA (Automated SYstem for CUstoms DAta) software, used by over 90 Customs Administrations around the World, was developed by the United Nations Conference for Trade and Development (UNCTAD). An earlier version of ASYCUDA called ASYCUDA++ was implemented in Vanuatu in 1999.

ASYCUDA++ is a DOS based program with ICT limitations and therefore obsolete in this day and age. UNCTAD has therefore developed a web-based version of ASYCUDA known as ASYCUDA World. It takes advantage of the significant progress made in the field of ICT to provide improved automated support to the evolving requirements of both the Trading Community and Customs administrations.
