DRIVERS LICENCE



Driving Licence

Every driver of a motor vehicle must be in possession of a driving licence delivered according to provisions of Section 44 of the Road Traffic Control Act [Cap 29].

How do I get a driving licence?

You are required to have a learner's licence before obtaining a driving licence. A learner's licence can be obtained from Taxpayers Services Office at a cost of VT 1,500 per licence category.

The licence is valid for one year and subject to renewal if required. Driving license can only be issued once the learner driver passes the driving test from the Vanuatu Police Traffic Section.

How much would it cost me to get a driving license?

It will cost VT 5,000.

How long is a driving license valid for?

Driving license is valid for 3 years.

Are there certain age requirements for getting a driving license?

The table below provides the age requirements for different license categories.

LICENSE CATEGORY	AGE REQUIREMENT
Motorcycle less than 50cc	<ul style="list-style-type: none"> Persons must be 14 years and over
Motorcycle 50cc - 125cc	<ul style="list-style-type: none"> Persons must be 16 years and over
Motorcycle more than 125cc	<ul style="list-style-type: none"> Persons must be 18 years and over
Motor Vehicle	<ul style="list-style-type: none"> Persons must be 18 years and over This category is a MUST when obtaining a drivers license
Heavy Motor Vehicle	<ul style="list-style-type: none"> This category is for heavy duty vehicles Applicant must have a motor vehicle category BEFORE applying for this license category Applicant must be 21 years and over Applicant must have a driving experience of at least 3 years

Common Vehicle

- Common Vehicle means every vehicle capable of transporting 8 persons or more, not including the driver
- Applicant must have a motor vehicle category BEFORE applying for this license category
- Applicant must be 21 years and over

My driving license has expired. What do I need to do to get it renewed and how much would it cost me?

All driving licenses must be renewed on or before the expiry date of the license. To renew your license you need to provide a valid medical certificate. Medical certificates are valid for 6 months only.

The renewal fee is VT 5, 000.

I have an international driving license that I want to use it in Vanuatu. How long can I use my international driving license?

Individuals with a valid international driving license are allowed to drive in Vanuatu for a period of 3months only. Those intending to stay in the country for more than 3 months are required to get a Vanuatu license by obtaining an approval from the Police Traffic Section.
