1. Les licences A,B,C,D,F,J,K,L,M,N,O, permettent la vente de toutes sortes de Boissons Alcoolisees.

2. les License C,G,I,Permettent la vente de vin et de biere seulement .

Licenses C,G,I, allow sale of wine and beer only.

An application should be completed for each separate premises.This application should be addresse to the clerk of Municipal.
