## IMPROVING COMPLIANCE IN THE LARGE TAXPAYER SEGMENT REGIONAL WORKSHOP

The Pacific Islands Tax Administration Association (PITAA) in collaboration with International Monetary Fund (IMF) and Pacific Financial Technical Assistance Centre (PFTAC) has offered online sessions based on improving compliance in the Large Taxpayer Segment facilitated by Georg Eysselein and Koni Ravono for the Pacific Member Countries.

The Inland Revenue Return and Debt Team Leaders; George Brechtefeld, Issen Tari and Andrew Norwo attended the Workshop with the Inland Audit Team Leader Aloma Borugu and Auditor Robyn Takiau. The compliance in Large Taxpayer Services session started on the 24 February 2021 and ended on 3rd March 2021 covering 14 Sessions altogether. The sessions has been very informative covering the importance of large taxpayers in reprioritizing revenue collections, applying compliance models in the large taxpayer environment and the key features of an effective large taxpayer compliance strategy.

Above all, the training was successful conducted and the Inland Revenue team looks forward to apply these knowledge gain in their work operations.



# OCEANIA CUSTOMS ORGANIZATION ONLINE TRAINING COURSE WITH THE CENTRE FOR CUSTOMS AND EXCISE

The Oceania Customs Organization (OCO) has offered online studies for Certificate III and Certificate IV in Regional Customs Administration for Valuation, Enforcement and compliance Management, Ethics and Governance, Risk Management, Cargo and Travellers, and Tariff.

The OCO professional standard framework is to provide the necessary knowledge, skills and competencies for regional customs staff to effectively perform their duties.

These online courses are divided into two streams Revenue and Enforcement. For each stream only 2-4 participants from each Customs Administration will be recommended by OCO from the list of Applications submitted to OCO Administration.

The First online course offered is Ethics and Governance Certificate III, and Vanuatu Customs is so fortunate that nine applicants were nominated for both stream five for Revenue stream (Queni Kenneth, Ann Warsal, Samuel Ben, Kalory Sope, Julieth Jacob) and 4 for Enforcement stream (Aquila Kency, Barry Narwayeng, Sandy Stephen, Roger Shem).

As a competency requirement, the Recommended Customs Officers must complete the six core subjects and complete two Electives subjects and comply to all the requirements of the online studies to be graded as competent and awarded the certificate III.

DCIR looks forward to the completion of these online studies for the recommended applicants and Officers who are attending these online courses.
